JBR was contracted by the Washington Department of Consumer Trade and Economic Development (CTED) to provide environmental services for completing Phase I Environmental Site Assessments (ESAs) for the Aberdeen Redevelopment Project. The Aberdeen Redevelopment Project includes the development of retail, commercial office, and high density residential housing centered on the remodeled Hotel Morck. The Phase I ESA project encompassed more than two city blocks, and was completed in a brief 40-day period. JBR was again selected by CTED to complete the Phase II ESA/ABCA portion of the project. The sites included former fueling stations, existing Leaking Underground Storage Tank sites, and other commercial properties.

## Project Experience

### Compliance Audits for Multiple Coal-fired Power Plants

JBR has performed comprehensive environmental compliance audits at more than 10 coal-fired electrical generation power plants in the Mountain West periodically over the last 15 years. These comprehensive environmental audits included a thorough assessment of existing permits and regulations related to air quality, stormwater, groundwater, solid waste, spill prevention, landfills, and several other facets of environmental compliance. JBR's compliance audit teams performed on-site evaluations to identify any gaps in compliance and provide recommendations for remedying any deficiencies. Work was performed under terms of strict confidentiality and under attorney-client privilege to minimize any risk to our clients. JBR has been repeatedly awarded this contract based on our thoroughness, ability to work with both corporate and plant personnel, and by meeting strict deadlines for final audit submittals.

### Phase I Assessment of Environmental Conditions for Property Transaction

JBR has conducted Phase I ESAs for property transactions covering large and remote acreages proposed for potential mining development. The most expansive of these properties was visually inspected by fixed-wing aircraft using a flight grid system and ground checked. Site-specific areas of potential concern or interest were documented and reports prepared to ASTM Standard E 1527-05. JBR has also conducted natural resource database reviews and permitting status reviews for such clients, to describe the potential complexities of permitting these areas for development.

### Confidential Client, Multiple Locations

JBR conducted complete environmental due diligence investigations for a client's acquisition of over 500 natural gas wells, gathering systems, and natural gas plants in Kansas, Oklahoma, Texas, and New Mexico. On a tight schedule, JBR designed the overall approach and built a team of both JBR and client field staff to meet the client's schedule. Our team mobilized, completed all field work, and issued findings in less than three weeks. A formula for valuing environmental liability costs was developed and applied to each tank battery, gathering system, gas plant, and well. Representative wells were inspected and all tank batteries and gas plants were inspected. Records of all state oil and gas commissions were reviewed for issues associated with regulatory compliance. All permits issued under the Clean Air Act were reviewed and followed up with review of state agency compliance records. Other selected records at all natural gas plants were examined and interviews with appropriate plant and field environmental personnel or managers were conducted.
